हिप्परगा तलावातून निवडणुकीत काढला ५३,२०० ब्रास उमेदवारांचे अर्ज

सोलापूर, दि.२: जलसंवर्धन लोकअभियानाच्या माध्यमातून, लोकसहभागाने हिप्परगा तलावाचे पुनरुज्जीवन करण्याचे काम हाती घेतले आहे. ५ जानेवारी रोजी सुरू झालेल्या या मोहिमेत आजवर ५३,२०० ब्रास गाळ काढण्यात आला असून, याचा ६ हजार शेतकऱ्यांनी लाभ घेतला आहे. गाळाची शेतकऱ्यांकडून मागणी नोंदवून घेण्यात आली असून, सध्या अडीच लाख टूक गाळाची मागणी आहे. जुलै महिन्यापर्यंत हे अभियान राबविण्याचे नियोजन केले आहे. दुष्काळावर कायमस्वरूपी मात करण्यासाठी शासनाने जलयुक्त शिवार अभियान सुरू केले. पहिल्या टप्प्यात २८० गावांत ही कामे झाली. आता या वर्षात २६५ गावांत या अभियानातून कामे सुरू आहेत. त्यामुळे अस्तित्वातील तलावांचा गाळ काढण्याचे काम जिल्ह्यात विविध ठिकाणी जोमाने सुरू आहे. आ. सुभाष देशमुख यांच्या पुढाकाराने तसेच भक्ती जाधव, सिध्देश्वर कदम, संदीप जाधव, संदेश जाधव या युवकांनी जलसंवर्धन लोकअभियानाचे काम जोमाने सुरू केले आहे. जिल्हा नियोजन समितीकडील चार पोकलेन, लोकमंगलचे दोन पोकलेन गाळ काढण्यासाठी सकाळी सात ते संध्याकाळी सातपर्यंत हिप्परगा तलावात काम करित आहेत. सध्या तुळजापूर रोडवरील हॉटेल शीतलसमोरील बाजूस हे काम सुरू

असून, दररोज सुमारे ४ जात आहेत. शेतकरी स्वतःची जात आहेत. गाळ घेतला जात असून या केली आहे शिवाय त्या वाहनावर कारवाई यांनी सांगितले. प्रत्येक शेतकऱ्या टाकावयाचा आहे त्या घेऊन ते रिकॉर्ड ठेवले यांनी सांगितले. रविवार गाळ काढण्याच्या ठिकाण लोकमंगल, शेतकरी लोकअभियानाच्या माध्यमातून गाळ काढण्याचे काम यांनीदेखील या कामास दिले आहेत. खूप मोठे मोठे आहे. अजून खूप लोकमंगलने आजवर हे काम खूपच मोठे आयासाठी लागावेत, अनेक आ. सुभाष देशमुख यांच्या

वर वर्चस्व स्थापन करण्यासाठी विविध ठिकांचे नेते तयारीला लागले असले तरी आपर्यंत कोणाही मंडळाने युती अथवा गाडी केली नसल्याचे दिसत आहे. युती गा आघाडी करताना कोणत्या मंडळाच्या याला किती जागा येतील, त्यातून याला उमेदवारी द्यायची व उमेदवारी यारलेल्यांची नाराजी ओढवून घेण्यास योरीचा कोणताही धोका पत्करण्यास ती शिक्षक नेते तयार नाहीत. त्याम शिक्षक नेते देखील उमेदवारांबाबत ठेवून आहेत. प्राथमिक बँकेची णूक ही जिल्ह्यातील शिक्षकांसाठी णूक मानली जाते. बँकेवर या मंडळाचे व राहाते ते मंडळ जिल्ह्यातील
